

POKER CASH GAME – EARLY BIRD Bonus

CASINO:	Casino Salzburg
PROMOTION PERIOD:	7 April 2025 to 30 June 2025*
PLAYOUT PERIOD:	4:00 PM – 7:00 PM
PRIZE:	1x 200 euros in chips

*) except poker events

GAME MODE

The Early Bird Bonus is played in Texas Hold'em No Limit (from blinds 1/3) and Pot Limit Omaha (from blinds 2/2). The Poker Cash Game player with the highest hand (flush or higher) from 4:00 PM to 7:00 PM will receive € 200 in chips at 7:00 PM.

- There must be at least five players at the table.
- No showdown is necessary.
- In Texas Hold'em No Limit at least one hole card must be used and the board must be improved.
- In the event of a tie, the payout is split (no color scoring).
- The winners must be present at the payout.
- Does not apply to Bomb Pot games.
- With "Deal it twice", only the top board counts.

ELIGIBILITY TO PARTICIPATE

All visitors to the Casinos Austria AG casinos listed above are eligible to participate in the Poker Cash Game. Entry to the casino from the age of 18 in accordance with the Casinos Austria AG visiting and gaming regulations. Official photo ID required.

Employees of Casinos Austria AG and Cuisino GmbH, as well as any partners involved in the promotion, are not eligible to participate. The casino management makes the final decision regarding all aspects of the prize draw, in particular with regard to eligibility to

participate, the validity of the participation cards and the course of the prize draw. Legal recourse is excluded.

Casinos Austria AG reserves the right to suspend or terminate the promotion within the promotion period without giving reasons or to exclude visitors from participation, in particular in the event of violations of these conditions of participation.

We would like to point out that legal or official regulations to prevent the spread of diseases (e.g. COVID-19 etc.) may come into force during the promotion period, which may completely prohibit the promotion from taking place during the promotion period, make it unreasonably difficult for casino visitors or make adjustments or postponements necessary. Should Casinos Austria AG be prevented from running the promotion due to force majeure, these terms and conditions of participation will be adjusted unilaterally. Force majeure includes, but is not limited to, the impossibility of implementing the promotion due to legal or official orders or extraordinary natural events such as epidemics or pandemics (e.g. COVID-19). Should a provision of the conditions of participation or part of a provision be invalid, this shall not affect the validity of the remaining provisions and the conditions of participation. Austrian law shall apply exclusively to the implementation of the promotion, to the exclusion of the UN Convention on Contracts for the International Sale of Goods and the conflict of law rules.

The liability of Casinos Austria AG and its executive bodies, employees and vicarious agents arising from or in connection with the promotion, regardless of the legal grounds, is limited to cases of intent and gross negligence, with the exception of personal injury. Casinos Austria AG accepts no liability for lost chances of winning.

PRIVACY NOTICE

Casinos Austria AG processes the following personal data only in accordance with all applicable national and European data protection regulations.

Casinos Austria AG will process the personal data of the participants resulting from the points "Prize draw mode" and "Eligibility to participate" described above for the purpose of carrying out and processing this promotion and ensuring compliance with the conditions of

participation. This includes, in particular, the contact data required to determine the winner and, in individual cases, additional information such as information on the issuing of participation cards, visits to the casino and participation in the Glücks Card program, insofar as this is essential for the implementation of the prize draw in accordance with these Terms and Conditions of Participation and this is described above. The processing of personal data is carried out on the basis of Art. 6 para. 1 lit. b of the GDPR (fulfillment of contract).
