

## **POKER CASH GAME – EARLY BIRD Bonus**

CASINO:	Casino Salzburg
PROMOTION PERIOD:	7 April 2025 to 30 June 2025*
PLAYOUT PERIOD:	4:00 PM – 7:00 PM
PRIZE:	1x 200 euros in chips

### GAME MODE

The Early Bird Bonus is played in Texas Hold'em No Limit (from blinds 1/3) and Pot Limit Omaha (from blinds 2/2). The Poker Cash Game player with the highest hand (flush or higher) from 4:00 PM to 7:00 PM will receive € 200 in chips at 7:00 PM.

- There must be at least five players at the table.
- No showdown is necessary.
- In Texas Hold'em No Limit at least one hole card must be used and the board must be improved.
- In the event of a tie, the payout is split (no color scoring).
- The winners must be present at the payout.
- Does not apply to Bomb Pot games.
- With "Deal it twice", only the top board counts.

### **ELIGIBILITY TO PARTICIPATE**

All visitors to the Casinos Austria AG casinos listed above are eligible to participate in the Poker Cash Game. Entry to the casino from the age of 18 in accordance with the Casinos Austria AG visiting and gaming regulations. Official photo ID required.

Employees of Casinos Austria AG and Cuisino GmbH, as well as any partners involved in the promotion, are not eligible to participate. The casino management makes the final decision regarding all aspects of the prize draw, in particular with regard to eligibility to



participate, the validity of the participation cards and the course of the prize draw. Legal recourse is excluded.

Casinos Austria AG reserves the right to suspend or terminate the promotion within the promotion period without giving reasons or to exclude visitors from participation, in particular in the event of violations of these conditions of participation.

We would like to point out that legal or official regulations to prevent the spread of diseases (e.g. COVID-19 etc.) may come into force during the promotion period, which may completely prohibit the promotion from taking place during the promotion period, make it unreasonably difficult for casino visitors or make adjustments or postponements necessary.
