

## POT LIMIT OMAHA – Cash Game Special

### MODE

The high hand is played in Pot Limit Omaha (from blinds 2/2). The player with the highest winning hand (from Full House) will receive 200 euros in chips at 01:00 on the respective game day.

- There must be at least five players at the table.
- No showdown is necessary.
- The winning hand must be shown.
- The floorman must confirm the high hand.
- In the event of a tie, the payout is split (no suit evaluation).
- The winners must be present at the payout. If they are not present, the winnings are forfeited.

### ELIGIBILITY TO PARTICIPATE

All visitors to the Casinos Austria AG casinos listed above are eligible to participate in the Poker Cash Game, Omaha Pot Limit. Entry to the casino from the age of 18 in accordance with the Casinos Austria AG visiting and gaming regulations. Official photo ID required.

Employees of Casinos Austria AG and Cuisino GmbH, as well as any partners involved in the promotion, are not eligible to participate. The casino management makes the final decision regarding all aspects of the prize draw, in particular with regard to eligibility to participate, the

validity of the participation cards and the course of the prize draw. Legal recourse is excluded.

Casinos Austria AG reserves the right to suspend or terminate the promotion within the promotion period without giving reasons or to exclude visitors from participation, in particular in the event of violations of these conditions of participation.

We would like to point out that legal or official regulations to prevent the spread of diseases (e.g. COVID-19 etc.) may come into force during the promotion period, which may completely prohibit the promotion from taking place during the promotion period, make it unreasonably difficult for casino visitors or make adjustments or postponements necessary. Should Casinos Austria AG be prevented from running the promotion due to force majeure, these terms and conditions of participation will be adjusted unilaterally. Force majeure includes, but is not limited to, the impossibility of implementing the promotion due to legal or official orders or extraordinary natural events such as epidemics or pandemics (e.g. COVID-19). Should a provision of the conditions of participation or part of a provision be invalid, this shall not affect the validity of the remaining provisions and the conditions of participation. Austrian law shall apply exclusively to the implementation of the promotion, to the exclusion of the UN Convention on Contracts for the International Sale of Goods and the conflict of law rules.
